



MEMORANDUM OF UNDERSTANDING ON COOPERATION

between

NHA TRANG UNIVERSITY

2 Nguyen Dinh Chieu, Nha Trang, Vietnam and MEIHO UNIVERSITY

23, Pingguang Rd., Neipu, Pingtung, Taiwan, R.O.C

In order to develop further friendship between the peoples of Viet Nam and Taiwan, to encourage academic exchange and collaboration between our two institutions, and to advance teaching and research in our respective institutions, Nha Trang University (NTU) and Meiho University (MU) make an agreement as follows:

- 1. Both institutions consent to establish a cooperative relationship, through which each institution will expedite the academic exchange of information about teaching, research and other matters.
- 2. Depending upon mutual agreement and the availability of funds, cooperative programs exemplified by any on or more of the following may be pursued:
 - 2.1 exchange of teaching and research personnel
 - 2.2 exchange of administrative and other professional personnel
 - 2.3 exchange of students
 - 2.4 collaboration on research projects
 - 2.5 collaboration on symposia and other academic meetings
 - 2.6 exchange of academic data and information
 - 2.7 engaging in special projects of mutual benefit
 - 2.8 joint or dual degree program ranging from certificates to graduate programs
 - 2.9 assistance in matters of curriculum
 - 2.10 collaboration on e-Learning program and promotion

For any specific cooperative program, mutual agreement will be reached and associated documents will be signed.



- 3. To assist cooperative relationships between our two institutions, each institution will, as far as it is reasonably able, provide access to research, library, computing, office and similar support facilities for visiting personnel, as is appropriate and as will be agreed upon, for each cooperative program.
- 4. Each institution will use its best endeavours to arrange suitable accommodation for visiting personnel and students from the other institution. Each institution will provide advice and assistance for procedures such as application for scholarships, travel funds, visa and short-term residence requirements, and local security approvals. Each institution will be responsible for ensuring travel and living expenses for its own personnel and students unless agreed otherwise for a specific cooperative program.
- 5. Faculty departments, administration centers and other organizational units of each institution with personnel and students are encouraged to develop and maintain appropriate contacts within the framework of the cooperative relationship between the two institutions.
- 6. This agreement will be valid for 5 years. It will be valid once it is signed by the official representatives of the two institutions. If either party wishes to terminate this agreement, written notice must be submitted to the other party six months before the desired termination date. However, ongoing projects should be completed and not be affected by the termination of the agreement.
- 7. This agreement is officially written in English, and is agreed upon by the Rector of Nha Trang University, and the President of Meiho University.
